

truck to collect cans in McPherson, Saline, Dickinson, Marion, Harvey and Rice Counties. He also personally pays the monthly fees to provide recycling containers around McPherson. Thanks to his efforts, he has provided \$38,000 (the equivalent of 77,000 pounds of aluminum cans) to the program allowing for 55 veterans to travel.

Rollover Your IRA for GOOD

By taking a distribution from your IRA this year, you will likely pay more in taxes and may even reach a higher tax bracket. **Rolling over** part of your IRA's "required minimum distribution" or "RMD" to a fund held at the Foundation can help reduce your tax bill while supporting the organization's cause.
