Phone call to enrollment-

LCDC is asking parents about possible duplication on waitlists, most often the answer is yes but not going so far as putting a deposit down. Using brightwheel to track.

Family parent's on disability, so there is a barrier for cost due to ineligibility for DCF. LQBTQIA parents find the faith based center intimidating. Looking for scholarships for assistance. Language in what types providers are home vs relative care vs center is confusing.
